2. A proof of address dated within 3 months (e.g., utility bill, bank/credit card statement) for the account holder(s) whose ID(s) does not contain the address.

If the two account holders **do not reside at the same address**:

1. A copy of valid government-issued photo identification documents for both account holders; and
2. An official document proving the relationship:
  - For spouses in a marriage/civil union/common-law relationship: marriage certificate, civil union contract, or other applicable documents.
  - For parent & adult child: birth certificate of the child or other applicable documents.

**Please note that additional information might be requested upon the review of your application.**

**Section 4 - Declaration and Signature of Account Holders**

We hereby acknowledge and understand that Kitco is authorized to act on the instructions of either one of the Account Holders, without further responsibility or obligation for further inquiry. This may include, without limitation, the following:

2. Each of the named account holders, acting alone, is authorized to deposit, withdraw or transfer funds or metals, and receive payment of any balances in their own name or even close the Joint Account;

4. Each of the named account holders shall be jointly and severally responsible and liable for the Joint Account; and
5. The account is a Joint Account with right of survivorship except for accounts where either of the named account holders resides in the Province of Quebec.
